Terms and conditions of appointment of Vice-Chairman and members of the Aayog:


1. The Vice-Chairman and non-official members of the Aayog shall hold office for a period of three years in State from the date of appointment.
2. The Vice-Chairman and non-official members may, by way of notice in writing under their hand addressed to the Government of Himachal Pradesh, resign from their office.
3. In the event of vacancy of a Vice-Chairman and non-official members due to death, resignation, removal or otherwise before the expiry of their term of office, a casual vacancy shall be deemed to have occurred and such vacancy shall be filled as early as possibly by nomination for the remaining term.

4. The salary, honorarium, and allowances etc. if any, payable to the Vice-Chairperson and members shall be such as may be prescribed.
5. The Vice-Chairman and non-official members may resign their office in writing under their hand and addressed to the Government.
