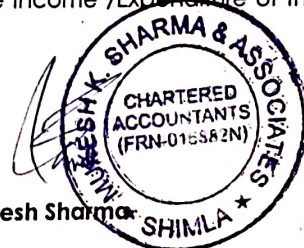
2. We certify that the balance sheet and the Income & Expenditure a/c are in agreement with the books of account maintained.

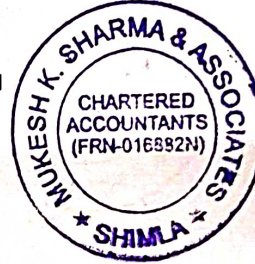

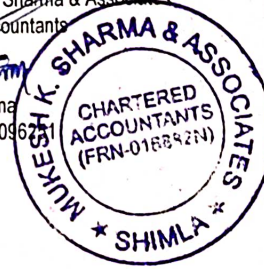

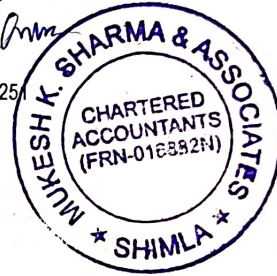
